CIRCULAR

Lr. No. AHCT/4-17/ EDM (Change of Mgmt. Intimation)/Dated: 28 - 07 -2015.

Sub: AHCT- Certain instructions- Prior intimation to the Trust by the Network Hospital(s) in the event of Change, Shifting, Transfer of Management/Constitution, Building Premises of the Network Hospital(s) etc. – Mandatory requirement of Prior intimation to the Trust by the hospital(s) at least 30 days of such Change/Transfer.- Reg.

Ref. Empanelment and Disciplinary Committee (EDC) recommendations dated 26/05/2015.

It is informed to all the Network Hospitals under the Trust that, in the event of any Change, Shifting, Transfer of Management/Constitution of the Hospital / Person representing the Hospital / Name of Hospital / Ownership of the Hospital / Entity/Unit of the Hospital / PAN Card of Hospital / Change of Bank Account(s) of Hospital / Change in Building premises of the hospital / its Renovations/Repairs/Shifting / Addition of the portion premises to the Hospital / Deleting the portion premises / Sell / bequeath / Transfer / Lease / Mortgage / Merge / Demerging the Hospital / Amalgamate / Any Change of Scheme of Arrangement related to the Hospital / propose to get de-empanel the hospital from the Scheme of the Trust / or else Close down the hospital, then under such circumstances it is mandatory and binding upon the network hospital(s) to provide prior intimation to the Trust at least 30(Thirty) days of such Change/Transfer etc. with the supporting relevant documents.

In this connection, upon the receipt of application of the hospital(s) with its relevant material, to effect the above Change/Transfer in the Trust's record, the EDC will decide the matter on case to case basis depending upon the facts, circumstances, situation and the legality governing the matter in the best interest of the Scheme(s) of the Trust and its beneficiaries. The stipulations narrated in Term 11.19 of the "Guidelines for Rajiv Aarogyasri Scheme" (Manual) read with Article 3(11) of the GCC of the SCA and the relevant laws are applicable thereto.

Hence all the Network Hospitals, in case of any Change/Transfer of the Management etc. of the hospital(s) as above stated, shall provide prior written intimation to the Trust at least 30(Thirty) days of such Change/Transfer, and follow the procedure thereafter, as laid down in Guidelines of the Scheme(s).

Any non-compliance of the above by the Network Hospital will be viewed seriously by the EDC of the Trust and the appropriate action i.e Disciplinary Proceedings will be initiated against the erring NWH, including the prosecution as per law in the interest of the Scheme(s) of the Trust and its beneficiaries.
